

- 1. Application must be completed in full and executed by the mayor and councilmen/aldermen, members of a police jury, or members of a cemetery board or commission established for the purpose of operating and/or managing a publicly owned cemetery.
- 2. Application fee in the amount of six hundred dollars (\$600.00). Please make check or money order payable to the Louisiana Cemetery Board. <u>NOTICE: Pursuant to LAC 46:XIII.701(B): If the applicant fails to submit the necessary documentation needed to complete an application, or the application remains incomplete and pending for a period in excess of 180 days without the applicant applying for and being granted an extension for good cause shown, the application shall be considered void, and any application fees paid in conjunction therewith shall be forfeited by the applicant and shall not be refunded; thereafter a new application for license must be submitted by the applicant, together with the payment of the applicable application fee without credit for any fees previously paid.</u>
- 3. The following documents must accompany the Application for Certificate of Authority:
 - *a)* <u>CERTIFIED</u> copy of charter of, or statute creating, the governing authority, which acquires, establishes, or maintains one or more public cemeteries.
 - b) <u>CERTIFIED</u> copy of governing authority's title to property, lease, or other agreement authorizing applicant to operate a cemetery on the property. A CERTIFIED copy is secured from the Clerk of Court in the Parish where the property is located and must contain a certification of the original recording.
 - c) <u>If a new cemetery</u>, certificate of city and/or parish planning commission/agency having jurisdiction over zoning matters stating the property on which the cemetery is to be located is properly zoned for that purpose and cemetery authority has complied with zoning ordinances, sanitary rules, and regulations, and the like. <u>If no zoning exists</u>, the Board must be provided with a statement from the city and/or parish planning commission/agency having jurisdiction over zoning stating same.
 - d) <u>CERTIFIED</u> copy of Act of Dedication. Sample Act of Dedication is enclosed for your use. A CERTIFIED copy is secured from the Clerk of Court for the Parish in which the cemetery is located, once the original Act of Dedication has been filed in the conveyance records. <u>If cemetery is in existence</u>, submit a confirmation letter advising portions of property dedicated and undedicated.
 - Pursuant to La. R.S. 8:1(7) and 8:907, a section of a cemetery can be dedicated for the interment of the human dead and cremated pet remains only. The interment of cremated pet remains within a specifically designed section is not a requirement under the law but is at the discretion of the cemetery authority. Please complete the Act of Dedication which is specific to either the interment of human remains, human and cremated pet remains, or an amended Act of Dedication to allow for the interment of cremated pet remains within a specifically designed section within an existing cemetery which previously was dedicated for the interment of human remains only.
 - *e)* A survey or plan of the cemetery property site.
 - f) A survey or plan of the cemetery, showing sections, blocks, plots, avenues, walks, or other subdivisions with descriptive names and numbers. <u>If a new cemetery</u>, the areas to be initially developed should be delineated on the survey. <u>In the case of a mausoleum or columbarium</u>, a substantial map or plat delineating the sections, halls, rooms, corridors, elevations, or other divisions with descriptive names and numbers.
 - *g)* Mortgage certificate from the Clerk of Court or Recorder of Mortgages showing the property on which the cemetery is located is free and clear of all mortgages, liens and encumbrances. <u>Mortgage certificate must</u> <u>be run in the name(s) of all persons or entities owning the property in the last ten (10) years.</u>
 - *h*) Itemized statement estimating cemetery receipts and expenditures for the next two (2) years.
 - *i*) Form of a cemetery deed, title, or certificate of interment right
 - *j*) Form of cemetery sales contract and/or purchase agreement
 - *k*) Cemetery rules and regulations

If assets, stock or membership interest of Cemetery Authority has been acquired through donation, the following will also be required:

I) Copy of the Act of Donation.

If the cemetery has an existing pre-need Merchandise Trust Fund, the following will also be required:

m) Any amendments to the Merchandise Trust Agreement. Either, confirmation Merchandise Trust Fund is remaining with present trustee; or if trust fund is being transferred to a successor trustee, all documentation required by La. R.S. 8:505.2 regarding orderly transfer of trust fund.

If the cemetery has contracted the services of a Cemetery Sales or Cemetery Management Organization. the following will also be required:

- *n*) Executed copy of all contract(s) between Cemetery Authority and Cemetery Sales or Cemetery Management Organization(s).
- 4. There shall be submitted to the Board such additional information and/or documentation the Board may deem necessary.
